Security:

It was noted that there was no new vandalism done to the kiosks in the park. Debby Pizur applied for a Rotary Club grant to fix kiosks in the future.

Treasurer Report:

Checking balance is \$2,557.61. Savings balance is \$3,458.35. Park People balance is \$10,421.10. Total balance is \$16,457.06.

Road Repaving request:

Rick Kaiser drafted a letter to Supervisor Steven Shea to repave the main road in the park. Road work is typically not one of our priorities. He discussed the logistics of requesting scarce county funds, and thought we should focus on the worst areas of the road to minimize cost. He suggested at a minimum repaving between Area 5A and Area 4, as well as the road down to the beach. Chris Marifke requested that the entry to Wil-o-Way be included. She suggested that Adult Day Services be contacted to also send a letter, since client transit vehicles use the road daily. Lynn Crawford volunteered to contact Supervisor Shea and invite him to drive through the park prior to our next meeting, and then to respond at that meeting.

Board & Bylaws:

Members are defined as those whose dues are paid and can vote for board vacancies. No new changes were suggested to the draft of bylaws.

Website:

Our FOGP website is back up. After being locked out of the site for about 6 weeks, the site is now hosted by FOGP. Jody will work on adding new content to bring the site up to date.
