- 3. SEWRPC Dec. 12th Oak Creek Watershed meeting report-Alice Thompson reported. She shared a 1930 map of the construction plans for the pond. The dam's sluice gate is clogged. The surprise is that there is PCB at the mouth of the creek and near the blue bridge. The area is highly contaminated. It should require emergency removal. Water quality sampling results was shared and full results can be found by Googling Oak Creek restoration plan. It was agreed a letter should be written to DNR, SEWRPC, and our County Supervisor and cc our Mayor and SM health dept. Jackie and Debby will compose a draft letter to be shared with Parks and members.
- Bucyrus Grant project Survey for slope at Wil-O-Way and entrance to beach was completed by RA Smith's Gary Raasch. It was suggested to visit Lion's Den Park in Brown Deer to look at the steps that lead to lake. RA Smith has agreed to create a construction plan. Betsy will ask them to give us an estimate for completing the plan. Rick will ask if parks is still doing matching grants Betsy will contact Lake Association that does construction at reduced costs.
- 5. Missing Gargoyles at area 5 pavilion? The faces are at parks maintenance 68<sup>th</sup> and State. Parks would like us to get them fixed. Blake the Mechanical Services Manager is responsible for the gargoyles. Betsy volunteered to contact historical society for recommendation for someone who can restore the gargoyles.

- 8. Donation received Abert family \$200 donation. A big thank you to the whole Abert family.
- 9. Eddee Daniels: Presentation? He is a member of Preserve our Parks, former art teacher and photographer. He does nature talks associated with the photos he takes.

Sean Kelly, Unit manager for Grant Park, reported:

- 1. Leopold bench was moved. They were made by scouts at the request of natural areas. Stakes securing benches are not in concrete and are easily pulled out.
- 2. Construction schedule for repair of road has not been set yet. Wil-o-Way road is also proposed to be done as well as the beach road.
- 3. Gates are being left open intentionally. In freezing weather the locks freeze and cause delays in getting into the park and plowing. May leave gates open in the summer.
- 4. Tattered flag at the beach was taken down.

5. There is more beaver activity. Sean asked we report any beaver activity/damage we see to him.

Members reported large plank on one of the bridges. Recommendation was made to send a picture to Sean.

Pam reported a "Bluff" sign was lying in the bushes and she placed the sign on picnic table.
