**Spotlight Grant Park in Hiking Report:** The report is now available through the website [TravelWisconsin.com](http://TravelWisconsin.com). Pam, Justine and Patrick are reporters for the website, which lets potential hikers across the state know the trail conditions in Grant Park each week such as the Oak Leaf, Forked Aster and the 7 Bridges Ravine trails. Thank you, reporters.

**Wulff Lodge access update:** A permit was requested for use of Wulff Lodge for July 25 Suburban Soles walk and we submitted a fee reduction form. Betsy and Jody took measurements from the lodge for blinds and sent the information to Stephanie Oleszek, who had volunteered to get costs on blinds in a previous meeting. *Jody has since found a source for the blinds with the cost estimated to be \$136 for 17 mini-blinds, possibly with an 11% discount. (Stephanie was unable to match)*

### Wil-O-Way project / FOGP steps project on hold?

Parks was going to incorporate this steps project into the overall Wil-O-Way road project. Now, the steps will be delayed for a year. The design we supported was not the type of steps that parks has approved for the area. Road and parking lot improvement projects are going forward this year at Wil-O-Way instead of the steps. One difficulty for FoGP to fund the steps project is that Parks wants a funding balance in place before they approve the project but we cannot write grants for funding until we get approval from Parks.

The ravine along the beach is being decimated and the stone walls along the trails are leaning over and will require reconstruction. These are additional projects.
