Proposed Amendment to County ordinance, Section 47.08

This ordinance proposes to allow foraging in Milwaukee County Parks, which is now prohibited. County Supervisor Steve Shea joined us to hear Friends of Grant Park's views, which were unanimously in opposition. Public parks that are located in areas comparable in size to Milwaukee such as Cleveland, Chicago and Minneapolis do not allow foraging. A point was raised that if the county starts permitting consumption of plants and mushrooms from the parks and people become sick from what they ingest, the county may be sued. Another point made was that an inventory of vegetation must be completed in advance, so that the effects of any harvesting can be determined, and no inventory has been done.

Friends of Grant Park thank Steve Shea for joining us and also Supervisor Ryan Clancy who joined us for a tour of Grant Park earlier in the week.

While Steve Shea was present, the opportunity was taken to inform him of the lack of park personnel on Grant Park Beach, which leads to beach rules being ignored. Supervisor Shea stated he would look into the lack of personnel.

YouthWorks donation

For 8 weeks during the summer, Minneapolis-based YouthWorks sends young people on mission trips across the Midwest. YouthWorks members have spent 2 to 3 days per week for a period of about 8 weeks over the past 4 years in Grant Park removing invasives, assisting Master Gardeners, blocking social trails with brush and other tasks. This year alone Grant Park was provided 591 YouthWorks volunteer hours. Rick Kaiser motioned to donate \$500 to YouthWorks. Lynn Crawford seconded the motion. Motion passed unanimously.

Proposal to combine 2022 SM Garden Tour with FOGP Art Fair at Wil-o-Way

Proposed by Jackie Benka, this would be a new initiative. The large parking lot near Wil-o-way would be the venue. Wil-o-Way Master Gardeners Chris Marifke and Becky Gresser are in favor, and the group was in general agreement.
