Tom Gardner mentioned that the FOGP website is woefully lacking current information, and volunteered to assist Jody to bring it up to date.

Betsy Abert shared the final report she filed with the Southeast Wisconsin Invasive Species Consortium regarding a grant we received in 2018 for financial assistance with tools and herbicide needed for Weed*Out* programs. 460 hours of donated volunteer time was logged. FOGP received \$1,554 from SEWISC.

James Davies suggested we look into applying for a SPARK grant earmarked for repairs in parks for matching funds up to 50%. \$200,000 is designated in parks budget for this program. Application can be made on parks' website. James volunteered to assist. This might be a good way to fix our kiosks and the rusting guardrail along Lake Drive at the main entrance. Debbie Pizur alternately suggested we apply to Rotary Club for \$100 to fix kiosks.

Our interpretive signs for the ravine are not yet installed. The footings have been poured, but the weather prevented installation.

We would still love to share Julia Robson's experiences from the 2017 *Walk to Sustain the Great Lakes*. A film is nearly complete. Betsy will ask Julia to contact us when the film is ready.

Debbie Pizur and James Davies will meet to work on a draft for board and bylaws. Anyone wishing to help with this should contact Debbie Pizur.

Betsy asked everyone to help find volunteers for WeedOut. FaceBook has not been an effective way to find volunteers. We discussed different approaches to propose such as groups or individuals adopting a patch of the park; suggesting shorter blocks of time (as little as 30 minutes) to encourage any sort of participation; and trying to contact members of congregations, community colleges or corporate PR departments to invite groups of parishioners, students or employees for a work day in Grant Park.
